Presentation and Discussion: Reconstructing Judaism Pilot Racial Equity, Diversity and Inclusion Assessment- Rabbi Sandra Lawson	A brief bio of Rabbi Sandra Lawson: Rabbi Sandra Lawson (she/her) works with senior staff, lay leaders, clergy, rabbinical students, and Reconstructionist communities to help Reconstructing Judaism realize its deeply held aspiration of becoming an anti-racist organization and movement. In her role, Lawson is developing a series of anti-racist policies and trainings for the organization and its affiliate members. She also serves as a mentor to rabbinical students. Some of the JRC Board members will participate as a pilot group to conduct an anti-racist/equity and inclusion assessment tool, that she designed, during the months of Jan-March. A second group will do the assessment process in the Spring of 2022. At the March Convention we will present our findings and learnings alongside the other congregations in the pilot. There are four synagogues around the US and Canada participating in the pilot (differing in geography, politics, and size) This assessment tool will help us, as leadership, see where we are in making our space, liturgy, school and events safe from discrimination for people of color and welcoming to all marginalized groups.
